## SUBJECT: 48 HOURS ULTIMATIUM;

1. BARRICK PARTY TO PORGERA MINE MOA REVISED AGREEMENT AND ASKING STATE TO FIX A DATE TO RECOMMENCE THE MOA REVIEW

2. RECSINCED THE DECISION TO TERMINATED TOTAL CLEANING & JANITURIAL SERVICES LTD CONTRACT IN PROVISION OF JANITURIAL CLEANING SERVICES FOR THE PORGERA MINE

This 48 Hours Ultimatum is not just another correspondence from Porgera Landowners Association of a kind to be taken for granted, but it expresses desires of the SML population at large in the strongest possible terms with unilateral demand for Barrick to act within the confines of desired answers. And those answers are expected within the next 48 Hours.

We do not present this ultimatum and the two demanded items as a disputed points seeking for collective bargaining hence, providing the answers and way forward to determine the future in operation of the Porgera Mine by the stakeholders.

 Barrick being Party to the Porgera Mine MOA Revised Agreement and asking State to fix a date to recommence the MOA review.

The call for Barrick to become a party to the revised Porgera has been our Number One Ask from day one and thereof. Recalling undertaking from the high level plenary meeting hosted by the Hon. Byron Chan MP and Minister for Mining on the 20th June 2014 at the Ela Beach Hotel in Port Moresby and our hand delivered letter to Peter Sinclair, Vice President, Corporate Social Responsibility Barrick Gold Toronto on the 18th September 2014, and on these forums we made it plain clear that Barrick must

become a party to the revised MOA and expect yes answer in about three weeks. Instead, it has taken three months.

Therefore, we call for answer within 48 hours. Barrick will be a party to the revised Porgera MOA and advice the State accordingly to immediately recommence MOA review.

Rescinded the decision to terminate Total Cleaning and Janitorial Services Ltd contract in provision of Janturial services for the Porgera mine.

On the 6<sup>th</sup> June 2014, our MOA review committee wrote from Kokopo during the last review asking Barrick Niugini Ltd <u>not to</u> touch nor make any contractual changes to existing contracts where SML landowner companies an engaged to provide services until the MOA was completed with appropriate issues in relation to business opportunities for SML landowners secured. In particular, Ipili Porgera Investment Ltd and Total Cleaning & Janiturial Services Ltd where identified in that letter.

We do respect the decisions of management to run the mine and seen to be promoting women economic development, a PR exercise in the rush hour. We wish not to go into detail. In this instance Barrick has seen fit to undermine our review committees ask not to touch SML companies engaged in contract until such time the MOA review is completed with appropriate provisions in business preference are captured to reward the very affected SML landowners.

Whereas, Barrick has not acted in good faith but act out of context to undermine the intended outcome of the revised MOA.

Therefore, Barrick is given 48 hours ultimatum to rescind the decision to terminate Total Cleaning & Janiturial Services Ltd contract and effect reinstatement forthwith.

In summary, the actions and correspondence by the MOA Review Committee or PLOA and heir delegates are the under authority of the PLOA 24 LNC Agents on behalf of the SML people.

And we, the undersigned 24 LNC Agents have every reason to belief there is no dispute for collective bargaining to set the bargaining wheel into motion on the two items, instead expect answers Yes within 48 hours.
